NOTIFICATION

Dated Dispur, the 4th March, 2016

No. CAD. 239/2013/74: The Governor of Assam is hereby pleased to make the following rules further to amend the Assam State Film Policy Rules, 1994 herein after referred to as principal Rules, namely:-

Short title and commencement 1. (1) These rules may be called the Assam State Film Policy (Amendment) Rules, 2016
(2) They shall come into force on the date of their publication in the Official Gazette.

Insertion of new rules 2. (1) In the principal Rules, after rule 38, the following new rule 39 and 40 shall be inserted namely:-

“BOX OFFICE SHARE

39.Box Office Share in case of Assamese and local language films of Assam to be followed in all weeks should be 50-50

Producer’s Share : 50% in all weeks
Exhibitor’s Share : 50%

“INCENTIVE TO QUALITY FILMS

40. In the matter of providing incentive for production of quality films (Assamese and local language) it was approved to provide incentive in the form of financial assistance to the producers and to the Directors of atleast 30% of the films. In this regard it was agreed to follow the Maharashtra model for categorizing A & B of the films with the help of a Scrutinizing Committee and thus providing them incentives accordingly.

Category A films get an assistance of Rs. 40.00 Lakhs

Category B films get an assistance of Rs. 30.00 Lakhs

Films which failed to figure in the list of Category A & B will not be considered for any financial assistance.”
