The Department has also mandated that these services be provided through the online portal without any hard copy processes and physical touchpoints.

The online portal allows the submission, fee payments and approvals to be done in a completely online manner.


**Subject:- Regarding use of "XLN Software" for issuance of Drugs Licenses.**
